OTHER BUSINESS

The Council approved our proposal to add alternate members to the committee. We currently have two vacancies on the Steering Committee that will be appointed by Mayor Rowland and CM Vaught. Our committee will accept nominations for four alternate members and make recommendations to the city council. If you know of individuals who would like to serve as an alternate, please send their names to me and Carlos. Depending on how many we receive, we may want to appoint a small group from our committee to review the applicants and make recommendations to our committee.

According to the city council resolution forming the committee, absence at three consecutive meetings is considered a resignation. Absence at more than half of the meetings, whether or not they are consecutive, also is considered a resignation.

The city clerk is preparing an attendance report. Carlos and I will reach out to all the committee members who have not met the attendance requirements before removing anyone from the committee. We understand that the attendance requirement may have been overlooked or that there are circumstances that make attendance difficult.
