COI HEALTH DEPARTMENT

Lauren shared that COVID numbers had doubled and that the department is also seeing some pertussis cases.

Mac shared July 2025 data: 2 calls were greater than 15 minutes and AMR handled 771 Priority 1 calls and 2200 calls/month.

CENTERPOINT UPDATES

Maggie shared that there have been 127 STEMI activations with first medical contact (FMC) less than 90 minutes at 100%. The ribbon cutting for the free-standing ER at Lee's Summit and 23rd will be 9/10/25. EMS volume for this year has been up 3% to approximately 12,000.
